Special Terms & Conditions for Airlines

THAI Airways "TG"

- * SPA rate ex Indian Gateways is exclusive rate of screening charge, X-ray charge, Which Airport Authority of India bill TG, TG will invoice this charge to MS via ICH.
- * In case of the final destination is not Australian Gateways. TG shall invoice MS for the Rotation charge at Australian Gateways via ICH as current local rate accordingly.

Virgin Atlantic Airways "VS"

- *Local handling charges will apply to any shipments originating in the UK and departing on MS Flight from the UK
- *Local Security charges will apply to any "unknown" shipments received by MS.
- *AMS/ACI customs entry fees may apply in accordance with standard published MS policy.
- *Local handling and customs fees can be obtain from local MS offices at point of departure.

Hong Kong Airlines Limited "HX"

- *All consignments transferring from MS to HX Flight should either have conducted 100% X-Ray Screening or should be “Known cargo” from a Regulated Agent. Any charges that incurred by X-Ray Screening on Interline shipments should be absorbed by MS or its Forwarders / Agents / Shipper / GHA.
- *All consignments transferring from MS to HX should adhere with a “Cargo Security Certificate” (CSC) to Master Air Waybill (MAWB) as a proven as “Known Cargo” appropriate security controls. The CSC should be completed by MS or its Forwarders / Agents / Shipper / GHA.
